# GOLD LICENSE AGREEMENT

## Licensing Terms

This music license agreement (“Agreement”) is between you, the Purchaser, and the Artist, Timothy W. Webb, dba TinCanMusic.Studio (TCM.S), jointly referred to as the “Parties.” By purchasing this license, you agree to be bound by the following terms and conditions.

## Definitions

**Work:** A recorded musical composition available for license from TinCanMusic.Studio.

**Project:** One media production to which a Work is synchronized.

## TinCanMusic.Studio Non-Exclusive, Single Project License

By purchasing this License, TCM.S grants you the limited, non-exclusive, non-transferable, worldwide right and license in perpetuity to modify and use a Work in accordance with the terms and conditions of the Agreement and the Gold License in a single Project. You hereby agree to pay the license fee posted on the TinCanMusic.Studio website. Notwithstanding the single project use granted by a Gold License, a Work licensed under a Gold License may be distributed an unlimited number of times in connection with the underlying Project, expressly including translations thereof.

## Gold License Permitted Use

This license allows you to use the purchased Work in a single Project in the following ways\*:

Web Based, Non-Revenue Generating Distribution of a Licensed Work	
Personal Use	Weddings, Life Moments
Corporate Use	Web Based, Company Website, Presentations, Training
Student Use	Student Projects for Credit, Student Productions or Film
Entrepreneur Use	Vlogs, YouTube, Facebook, Indie Channel of Film
Apps, Games, and DVDs	Free Downloads

*\* If your Project is not listed above as a permitted use, please contact the Artist for a custom license.*

## Limitations of Use

### YOU MAY NOT:

- ⇒ Sell, transfer, sublicense, share, give away or otherwise assign the Works or your rights granted hereunder to any other party.
- ⇒ Resell the Work by itself or as part of a package except solely as embodied with your Project.
- ⇒ Resell the Work (or otherwise make it available) in any manner that would enable a third party to download the Work as a separate file, such as in e-card templates or website templates.
- ⇒ Resell the Work (or otherwise make it available) as part of any competing product such as music compilation or music library.
- ⇒ Sell the Work (or otherwise make it available) as, or as part of, your music or as your song, even if it has been transformed or edited, or if you add other instruments or vocals to the music.
- ⇒ Claim to be the creator or copyright holder of the Work or of any derivative work created from the Work.

## Ownership

You hereby acknowledge that TCM.S is and remains the owner of all right, title and interest in the Work, including without limitation any copyrights therein. The Work remains property of TCM.S and is subject to all United States and international copyright laws. With this TCM.S License, you may use a Work, but TCM.S retains ownership of the Work. This license is non-exclusive, and TCM.S retains the right to sell licenses of the Work to third parties at its discretion. You may not claim ownership of the Work (or otherwise make it available) through any content detection and/or registration system (such as YouTube's Content ID), even if synchronized with your own Project.

## Additional Terms

A Work licensed hereunder is for your own personal or professional Project, including those you undertake for your clients or for your employer. This License permits you to use a single Work in your Project, but it does not include public performance rights. The Artist is a Songwriter/Publisher member of Performing Rights Organization (P.R.O.) ASCAP, and each TCM.S Work is registered

with ASCAP accordingly. If you intend to use the P.R.O. Work in a Project that is *publicly performed*, cue sheets must be filed with ASCAP. TCM.S will provide all cue sheet information upon request, and a completed copy must be emailed to [TimWebb@TinCanMusic.Studio](mailto:TimWebb@TinCanMusic.Studio). Unless you are already in possession of a blanket license with ASCAP, you may be subject to additional fees which are collected by the P.R.O.

### Limitation of Liability

TCM.S makes no warranty or representation, express or implied, except that it warrants that it has the right to grant the license granted hereunder. The total liability of TCM.S under this Agreement arising from your use of any Work shall be limited to the license fee paid by you for such Work. You hereby agree that this license is granted to you without any other warranty or recourse.

### General Provisions

This Agreement shall be governed by and construed according to the laws of the state of Nevada, U.S.A. Nothing in this Agreement shall be interpreted as constituting or creating a joint venture or partnership between the Parties. This Agreement shall be to the benefit of and bind the respective heirs, executors, administrators and assigns of the Parties hereto. If any part of this Agreement is determined to be invalid or unenforceable by a court of competent jurisdiction or other legally constituted body having jurisdiction to make such determination, the remainder of this Agreement shall remain in full force and effect.
